Thank you for your interest in engaging Intuitive Services, LLC to provide the services of Maryann Kelly (“Maryann” which are globally available via Zoom. Intuitive Services, LLC is providing you with the following information so that clients are informed regardless if a client has one session or participates in several sessions in one or more services offered so you can make an informed choice about your decision to engage Intuitive Services, LLC to provide her services.

Confidentiality: Due to the personal and sensitive nature of Intuitive Services Insight® services, Maryann agrees to keep session information confidential to the extent possible via ZOOM and similar telephone or electronic platforms as applicable, and, except as may be required by law, agrees not to disclose same to others. With the exception of pictures or recordings taken by or on behalf of Intuitive Services LLC (“IS”) for Intuitive Services Insight® events, documentation, social media, etc., Client acknowledges and agrees that IS and Client will not take photos, do screen scraping, and will not capture audio or video recordings as such may compromise confidentiality and/or service integrity.

Proprietary Information: You, the client, understand that the tools, practices, processes, and materials utilized during sessions or seminars are confidential, proprietary, and subject to Trademark protection as applicable. Therefore, Client agrees not to duplicate, teach, or train using any of such tools, practices, processes, and materials utilized during the sessions or seminars, in any manner, without the prior written permission of Intuitive Services LLC (“IS”). Client agrees to receive periodic Intuitive Services, LLC updates or newsletters while client has the right to unsubscribe at any time.

As I, Client, am responsible for my own life choices, and choices related to the health of my children/dependents, pets, and property, I acknowledge that the sole purpose of the sessions or seminars is to provide me, the Client, with alternatives/information that I, in my own absolute discretion, may choose to use, or participate in for me, my children/dependents, for those for whom I am a guardian, my pet, or my property. In Spirit Mediumship sessions, it is not up to Maryann Kelly/IS as to who chooses to come through and speak to loved ones. It is Maryann Kelly/IS’s work in partnership with the Client, to set the highest intention for the best outcome regarding all IS services rendered for all present. No representation is being made by IS or Maryann Kelly as to the accuracy or usefulness of any information/service being provided to me by IS or Maryann Kelly.

### **1. Services Offered**

Maryann offers her services as an Alternative Healing Arts Practitioner providing intuitive assessments and readings; mediumship; energy modalities, clearing, and balancing for individuals, animals, and property; and shamanic processes. The approaches she primarily uses in her practice are **Holistic Health, Medical Intuition, Mediumship, Emotional Freedom Techniques (EFT), Shamanism, Past Life Regression, Scalar Wave,** and **Intuitive Mentoring & Coaching**, all of which are considered part of the field of Complementary and Alternative Medicine (collectively the “CAM Methods”). Maryann specializes in using the CAM Methods to help her clients obtain information from alternative pathways in the energetic and non-physical realms for a holistic approach to health and well-being. She focuses on assisting her clients to access their own wisdom for personal growth, spiritual development, and self-healing. In addition, she offers her services for those dealing with overwhelming life experiences and cult recovery. Maryann may also, depending on the client’s comfort level, offer additional energy-oriented techniques, if she feels that they would be helpful. Please be advised you have the option of using individually or collectively recommended CAM Methods offered by Maryann as part of your work with her. Some of the more advanced services require a prerequisite initial session. For further information regarding the CAM Methods, please refer to the **Additional Client Information & Office Policies** document which is attached hereto and made part of this Agreement.

## **2. CAM Methods/Theoretical Approach**

CAM Methods is a collective term used to refer to a variety of alternative techniques, approaches, methods, and intuitive assessments based on the use and modification of energy fields and other spiritual and metaphysical processes. They are intended to help improve overall health and well-being and for personal growth and spiritual development. The prevailing premise of the CAM Methods is that the flow and balance of the body's electromagnetic and more subtle energies are important for physical, emotional, mental, and spiritual health, and for fostering well-being.

Although the CAM Methods appear to have promising health benefits, and there is a growing amount of scientific research indicating that EFT meets the criteria to be considered an evidence-based technique for managing stress, they are considered outside traditional Western approaches to health and wellness. Therefore, they have yet to be fully researched by the Western academic, medical, and psychological communities. Consequently, the CAM Methods are considered experimental. The CAM Methods are self-regulated and no state in the United States licenses practitioners of the CAM Methods and considers them to be *alternative* or *complementary* approaches.

## **3. Nature of the Relationship**

***By signing this document, you understand that Maryann is offering her services solely as an Alternative Healing Arts Practitioner offering the CAM Methods. She is not a psychotherapist, physician, or any other licensed health care provider nor are her services licensed by the state of New Jersey. Therefore, your relationship with Maryann is not to be construed as psychotherapy, medical treatment, or any type of licensed health care service.***

In addition, you understand that as a practitioner of the CAM Methods, Maryann does not provide any medical, psychological, veterinary, or any other licensed health care advice, opinion, or service and does not diagnose, treat, or cure any disease, condition, or other physical or mental ailment for individuals or animals. Also, although Medical Intuition uses the term "medical", it is not to be construed that the use of the CAM Methods is the practice of medicine, veterinary medicine, psychotherapy, or any other licensed health care practice. Rather Maryann offers her services to clients with the intention to assist them in restoring balance and energetic flow in the body; thereby, creating the opportunity for the client to be empowered for mind/body/spirit to heal naturally. You understand there is a distinction between "healing" using the CAM Methods and the practice of any licensed health care practice.

## **4. Other Important Information Regarding the CAM Methods**

You understand that the services Maryann offers, and the use of the CAM Methods are **not** intended to be a substitute for medical, psychological, or veterinarian diagnosis or treatment and they do not replace the services of licensed health care providers. If your session is for you personally, you agree and understand it is your responsibility to consult with your licensed health care provider for any specific health care problems. If your session is for your animal, you agree to consult with your animal's veterinarian for any specific health care problems. Further, if your session is for you personally, you understand that any information shared during your session is not to be considered a recommendation that you stop seeing any of your licensed health care providers or using prescribed medication, if any, without consulting with your licensed health care provider, even if after your session it appears and indicates that such treatment or medication is unnecessary. In addition, if your session is for your child; someone for whom you are guardian; or for your animal, you understand that any information shared during a session is **not** to be considered a recommendation that the associated person(s) or animal stops seeing his/her licensed providers or veterinarians or using prescribed medication, if any, without consulting with your licensed provider or veterinarian, even if after working with you, your child, the person for whom you are the guardian, or for your animal it appears and indicates that such treatment or medication is unnecessary.

## **5. Outcome Expectations/Risks and Benefits**

## **1. CAM Methods**

### **Holistic Health & Medical Intuition**

Holistic Health uses intuitive assessments as tools for supplementary insight to discern energetic imbalances and to uncover vibrational energy patterns that may be causing health challenges for the client. Medical Intuition is defined as a system of expanded perception gained through the development of the human sense of intuition. Medical Intuition focuses on visualization skills and in-depth intuitive scanning to obtain information from the body and energy system for health and well-being. A Holistic Health and

Medical Intuition reading is intended to bring into conscious awareness information to assist clients in addressing issues or concerns.

### **Mediumship**

Mediumship is considered the practice of using clairvoyant or intuitive abilities with the intention to tune into the spirit energy surrounding the client, including the client's Higher Self. The premise is that a medium can receive information directly from the Higher Self and also those who have transitioned from their physical life to their spiritual life as well as spirit guides and angels. Maryann relies on the presence of non-physical energy outside of herself for information relevant to the client being read. While it is not possible to provide any guarantees, Maryann can attempt to make connections with and deliver messages from people who have transitioned to their spiritual life to those who are still here. In Spirit Mediumship sessions, it is not up to Maryann as to who chooses to come through to share messages for loved ones. It is Maryann's work in partnership with you, the client, to set the highest intention for the best outcome regarding all IS services rendered for all present. Maryann makes no representation that any information provided is accurate or useful.

### **Emotional Freedom Techniques (EFT Tapping)**

EFT is considered an innovative energy-oriented healing and self-help technique based on the newly emerging field of energy psychology. EFT seeks to address imbalances within a person's energy system, as well as the energetic influence of thoughts, beliefs, and emotions on the body. The prevailing premise of EFT is that the cause of all challenging, stressful, and/or negative emotions is a disruption in the body's energy system. It is believed that EFT helps clear these disruptions, thereby calming the mind and restoring the flow and balance of the body's electromagnetic and more subtle energies. EFT uses the ancient Chinese meridian system with a gentle tapping procedure which stimulates designated meridian end points on the face and upper body while saying specific phrases and focusing on stressful issues in order to release the intensity of the stress and to reframe the issues. In an EFT session, the client does the tapping on the client's own body and the practitioner helps guide the session by instructing the client where to tap. If you are not able to "tap" for yourself, then Maryann may need to remotely "tap" for you.

### **Shamanism**

Maryann offers a form of spiritual healing known as shamanic healing arts that may include a variety of spiritual healing methods, including power ally and soul retrieval, energetic cord removal, extraction of negative energy, removal of foreign energy by compassionate depossession and psychopomp. She also offers shamanic divination work designed to seek guidance from compassionate Helping Spirits in order to address specific issues, problems, or questions (collectively the "Shamanic Processes"). Shamanic Processes are intended to access spiritual realms for personal healing, growth, and transformation. Using the Shamanic Processes, Maryann is guided to interact with her client's Higher Self and Spiritual Guides to help restore balance and wholeness for the client. A shamanic practitioner operates primarily within the spiritual world, which in turn can positively affect the physical world.

### **Past Life Regression**

Past Life Regression is intended to take the client back through time to their previous lives or incarnations by accessing experiences that are normally hidden in their subconscious mind. Past Life Regression may be helpful in understanding issues that are of concern in the client's current life.

### **Scalar Wave**

Scalar Waves are considered an energy healing technique that uses energy waves or scalar waves for health and well-being. The materials that are used in this technique relate to quantum science and quantum energy. This technique utilizes scalar energy frequency that can help enhance, motivate, protect, and balance the client's autonomic nervous system, and it can also reduce stress. It can also be useful in reducing feelings that are associated with habitual actions, which are negative, and helps in detoxifying cells and promoting relaxation.

### **Animal Communication**

If your session is for your animal, Animal Communication may be incorporated into your session. With Animal Communication, the practitioner intuitively tunes into the animal to receive information from the animal regarding the particular issue presented. An animal session is designed to discern the energetic

cause of a problem or issue and then to neutralize it; thereby creating the possibility that a positive change can occur which may be experienced.

### **Intuitive Mentoring & Coaching**

Intuitive Mentoring & Coaching is designed to enable clients, through intuitive readings, to receive insights, wisdom, and direction from the client's Higher-self and others in the non-physical world with the intention to provide support for spiritual and energetic growth and expansion for the client. Session may include, but are not limited to, mediumship, intuitive readings, support, practicing skills together, coaching, homework, structure, and tracking progress.
